2. Minutes & Actions from AGM held 3rd May 2019

- One change since the Minutes were issued: Sian Liwicki was replaced as Treasurer by Christopher Cooke. This change was voted in by 22 members by e-mail on 15/10/19.
- Minutes were approved.

3. Chairman's Report: Bob Nielsen

- Apart from the COVID-19 pandemic which has affected everyone this year, the major issue facing most T&CVA vineyards in 2020 was the severe late frosts in May which were the worst that many had seen in 20 years and reduced harvest yields between 50 and 100%.
- It was suggested that because the T&CVA region consists of valleys and hills, we suffer from a greater variation of microclimatic conditions than other Wine GB Regions and it may be worth considering a more in depth survey of the vineyards in our region to look at topography and

- explore which frost prevention methods work best for us. This suggestion to be taken forward separately.
- WineGB have been extremely active this year and have done a Stirling job in keeping members
 updated with COVID restrictions, and marketing English & Welsh Wines to keep businesses
 afloat under very challenging circumstances. We wish to recognise how much we appreciate
 their efforts and encourage all T&CVA members to use them as a resource.
- The T&CVA Annual Wine Challenge was successfully and safely held despite COVID challenges.
- The English Wine & Food Festival 2020 was postponed due to COVID restrictions and has been rescheduled for June 5th & 6th 2021. A GO/NO GO decision will be made in March before we incur huge expenditure.

4. Vice-Chairman's Report: Patricia Stefanowicz

- TCVA Wine Challenges held Sept 13th 2020 at Brightwell Vineyard with Vice-Chairman leading a
 panel of 4 highly qualified judges. Judges' comments sent to T&CVA Secretary for distribution to
 wineries.
- As Technical Advisor, extended visit to Mill Hill Allotment vineyard (formerly Andy Creighton) for discussion about renovating trellising and reinvigorating vineyard.
- Attended numerous WineGB 'events', specifically Viticulture and Winemaking, but also some on Marketing and Sales.
- Attended WineGB 'Secrets of the Soil' Viticulture Technical Conference, 17th-19th November

5. Treasurer's Report: Christopher Cooke

- The account balance as of the end of October was a healthy £4,454 (Y/E December 2019 was £3,211). As the Festival was postponed this year the only event in the calendar was the Wine Challenge. Although there was a small attendance for obvious reasons, this still produced income of £352 with £195 for wines entered (increased to £5 per wine) plus lunch income of £157. Total costs amount to £468 for judges, lunch and cup trophy engraving, thus a small deficit of £115.
- Regarding the postponed festival, we have reimbursed £473 to stall holders but a number requested we just hold the payment on account for 2021. This consists of £1,473: £973 of stall holder and £500 of sponsorship fees.
- Membership. There are 44 paid up members of TCVA of which 5 are new members. We received £1,000 of subscription revenue on account from WineGB in September with another £145 to come by the year end. Our year end is 31 December— in line with that of WineGB.
- Medal labels. We reprinted earlier in the year and following a call to arms to vineyards there was
 an excellent response to buying and 'sticking' during lockdown. We will need to reprint early
 next year as we are out of stock of our gold and silver medal labels.

- TCVA Wine Challenges held: Sept 7th 2019 at Oaken Grove Vineyard and Sept 13th 2020 at Brightwell Vineyard
- Very successful 1st English Wine & Food Festival (EWFF) held on June 8th 2019, Brightwell Vineyard, Wallingford: 13 T&CVA vineyards, 6 "Street" Food suppliers, 12 artisan food producers, Jazz quartet, 780 visitors, £3400 in sponsorship secured.
